## BMW Group Canada achieves best-ever October.

BMW and MINI brands maintain significant year-to-date edge over 2010.

**Richmond Hill, ON.** BMW Group Canada (BMW and MINI brands combined) reported 2,863 retails in October, an increase of 1.1 per cent over October, 2010. A total of 28,757 units have been sold so far this year, an increase of 9.8 per cent over last year.

#### BMW.

The BMW brand achieved its best ever October with 2,432 sales, an increase of 0.3 per cent over the same month last year. Year-to-date sales of 24,556 units represent an increase of 9.4 per cent compared to the same period last year.

### MINI.

MINI reported sales of 431 units in October, an increase of 6.1 per cent over October, 2010. MINI has sold 4,201 units year-to-date, an increase of 12.3 per cent over the same period last year.

## Motorrad.

BMW Motorrad Canada reported October sales of 105 units, an increase of 1.0 per cent compared to October, 2010. The year-to-date figure for the brand is 1,579 units, a decrease of 15.3 per cent compared to the same period last year.

## Pre-owned.

BMW pre-owned reported 1,296 units retailed in October, an increase of 3.3 per cent over October, 2010. Year-to-date, a total of 11,104 units have been sold, marking an increase of 3.8 per cent compared to the same period last year.

On the MINI pre-owned front, 172 units were sold, an increase of 67 per cent over October, 2010. Year-to-date, MINI pre-owned has sold 1,763 units, an increase of 47 per cent over the same period last year.
