Manual transmissions return to the Canadian MINI line-up after a brief delay in availability during the 2020 model year.

MINI Canada is pleased to confirm the latest range of MINI models to be offered with the choice of a standard manual transmission, for driving enthusiasts who enjoy shifting their own gears. As of March 2020, production has resumed for MINI 3 door, 5 door and Convertible models, including manual transmission choices.
