BMW Group UK national sales company moves to new Farnborough office campus

450 staff relocate from Bracknell to purpose-built site from 24 November 2014

BMW Group UK's sales and marketing organisation is moving into a newly refurbished, purpose-built office campus in Farnborough from 24 November 2014. Located in Summit Avenue, the new site will be known as Summit ONE and will see 450 staff relocating from the company's current office in Bracknell where the UK sales subsidiary was established more than thirty years ago.

Between now and 2017, a further 750 staff from the Group's financial services, leasing and fleet management companies, all currently based in Hook, will also move to the new site. This will bring together these BMW Group UK subsidiaries for the first time in one location and allow them to work more closely together to exploit new business opportunities.
